Security Uniforms

Initial Issue

Clothing

- (2) long or short-sleeve black polo shirts (in any combination) with embroidered rank-appropriate badge and rank-appropriate collar insignia
- (2) tan tactical pants
- (1) black lightweight jacket
- (1) pair boots or shoes
- (1) black waist belt

Duty Belt and Accessories (black basket weave) or Duty Vest and Accessories (black nylon)

- (1) duty belt or duty vest
- (4) belt keepers (duty belt/duty vest)
- (1) oleoresin capsicum (OC) spray holder
- (1) wrist restraint case
- (1) key holder
- (1) radio holder
- (1) glove pouch (duty vest only)
- (1) multipurpose pouch (duty vest only)

Additional Accessories

- (1) employee identification card
- (1) belt clip badge holder
- (1) metal rank appropriate badge
- (1) set wrist restraints
- (1) flashlight
- (1) coat, based on post and season of hire

At the end of initial probationary period (the end of the 4 week OJT)

- (3) tan tactical pants

- (3) long or short-sleeve black polo shirts with rank-appropriate badge embroidered and rank-appropriate collar insignia embroidered

To equal a total of five complete uniforms

Reissue

Replacement of non-serviceable uniform items on a one-for-one exchange up to but not to exceed five uniforms sets (pants and shirts). Employees completing their entrance level probation receive new shirts with rank appropriate collar insignias in exchange for the shirts of the prior position.

Food Service

Initial Issue

Clothing

- (2) long or short sleeve poly/cotton blend dark navy-blue polo shirts (in any combination), approved for food service use, with embroidered rank-appropriate badge and rank-appropriate collar insignia
- (2) tan tactical pants
- (1) black lightweight jacket
- (1) pair boots or shoes
- (1) black waist belt

Duty Belt and Accessories (black basket weave) or Duty Vest and Accessories (black nylon)

- (1) duty belt or duty vest
- (4) belt keepers (duty belt/duty vest)
- (1) oleoresin capsicum (OC) spray holder
- (1) wrist restraint case
- (1) key holder
- (1) radio holder
- (1) glove pouch (duty vest only)
- (1) multipurpose pouch (duty vest only)

Additional Accessories

- (1) employee identification card
- (1) belt clip badge holder
- (1) metal rank appropriate badge

Reissue

Replacement of non-serviceable uniform items is a one-for-one exchange up to but not to exceed five uniforms (pants and shirts).

Mechanical Services

Initial Issue

Clothing

- (2) short-sleeve tan button-up shirts (shoulder patch on left shoulder)
- (2) brown pants
- (1) black heavy work-duty winter coat
- Boots or shoes must be black or brown in color (tradesmen choose and purchase their own footwear best suited to their positions. After successfully completing entry probation, the tradesman is reimbursed up to \$150 for footwear).
- The maintenance operations supervisor is issued (2) long or short sleeve black polo shirts (in any combination) with embroidered IDOC logo and words 'Mechanical Services' on left breast pocket area.
- The maintenance operations supervisor is issued (2) tan tactical pants.

Leather Accessories (black basket weave)

- (1) black waist belt (leather)
- (1) key holder (leather)
- (1) radio holder (leather)
- (1) flashlight holder (leather)

Additional Accessories

- (1) employee identification card
- (1) flashlight
- (1) multi-purpose tool such as a Gerber® or Leatherman® (such tools must be handled in accordance with SOP [509.02.01.001](#), *Tool Control*.)

At the end of initial probationary period

- (1) black standard vest (IDOC logo on left breast pocket area with words 'Mechanical Services' embroidered)
- (3) shirts, same as initial issue
- (3) pants, same as initial issue

Reissue

- Boots or shoes –When boots or shoes are no longer serviceable, tradesmen choose and purchase their own footwear best suited to their positions and are reimbursed up to \$150. (Must provide purchase receipt for reimbursement)
- Replacement of non-serviceable uniform items on a one-for-one exchange up to but not to exceed five uniforms sets (pants and shirts).

Additional issue when appointed to vocational work projects

Initial Issue

- (1) black sweatshirt
- Any specialty clothing based on work assignment such as, two complete sets of Nomex® clothing if assigned to fire crews, fire appropriate footwear, etc.
- (1) black GORE-TEX® winter jacket (employee's option)
- (1) light-weight black jacket (employee's option)

Reissue

- Replacement of non-serviceable uniform items on a one-for-one exchange
